A mix of skills, experience (life or work!) and fresh ideas on the committee usually works best. Not everyone has to know everything and do everything!

Committee members from all regions of Tasmania - especially outside the South - are especially welcome.

It can be a really good way to learn more about jet skiing, as well as planning events and riding in Tasmania generally. People are often quite surprised what is involved in preparing and delivering a calendar of events every year!

Some roles have specific jobs nominated in the Constitution. Otherwise, the Committee decides what each position does, but a general guide is below.

Over the years, the Club has identified other internal roles that are really important to keep everything working. Any Committee can change these, although someone has to be the Membership Officer as it has specific tasks under the Constitution.

## President

- Keeps things ticking along in a reasonably organised way
- Helps the committee determine what it wants to do for the year and how to get there
- Chairs committee meetings and meetings of members
- Often the Club spokesperson if needed
- Meets with key stakeholders, usually along with Vice President or one of the other Committee members
- Might take on one of the other roles


## Secretary

- Coordinates the administration and correspondence
- Organises meetings and prepares minutes
- Keeps in touch with the President to ensure the Committee knows what is coming up next and what needs to be done


## General Officer

- Takes on one (at least) of the internal roles that need to be done


## Vice President

- Supports everyone especially the President
- Back up as chair of meetings and Club spokesperson if President isn't able to
- Takes on one of the other roles that need to be done


## Treasurer

- Keeps the Club's books
- Pays the bills, banks the receipts
- Prepares financial reports for committee meetings
- Looks after the bank account
- Organises the financial statements at year end and the auditor


## General Committee (up to 4 positions)

These positions share the other internal roles that need to be done each year.
